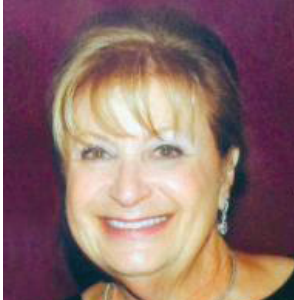


## THE SUSAN K. ASBELL MEMORIAL GALA
